1. My Dog(s) is/are fully vaccinated against Parvovirus, Hepatitis, Distemper, Parainfluenza and Bordetella and I have provided proof (C5).
2. My Cat(s) is/are fully vaccinated against Feline Enteritis, Feline Rhinotracheitis and Feline Calicivirus and I have provided proof (F3).
3. The A1 staff will make every effort to ensure all of your pets belongings are kept with your pet during their stay with us, but I understand that they accept no responsibility for items left, misplaced, lost or in lesser condition than when they arrived at the kennels.
4. I have provided reasonable information concerning special/medical needs and behaviours of my pet(s) and I have, to my knowledge, disclosed any health and behavioural concerns of my pets to the staff of A1 Kennels and Cattery.
5. I acknowledge that while A1 Kennels and Cattery and Dogtainers Darwin will take reasonable care, they cannot be held responsible for injury, death, loss or damage of any kind what so ever that may occur to any pet.
6. If in the event of the boarded pet(s) not being collected within fourteen days of the collection date stipulated, A1 Kennels and Cattery may dispose of the pet(s) in any manor they see fit and the owner shall have no claim whatsoever.
7. Clients are responsible to administer flea/tick control and worming prior to your pets stay. Occasionally we may be required to administer additional treatments to ensure your pets are healthy during their stay. Please note that such items will be payable upon collection of your pet(s), and will only be done if staff deems it completely necessary. A1 Kennels and Cattery will not be held accountable if any problems arise from these treatments.
8. If no tick protection has been administered prior to a pet by the owner, A1 has the right to refuse animals for board until such time as the treatment has been given. Clients must be aware that even though A1 takes all due care regarding the prevention and treatment of ticks, it is not possible to guarantee that these instances will not occur. A1 does not take any responsibility in the instance that a pet suffers from tick poisoning, even if sufficient treatment has been administered.
